

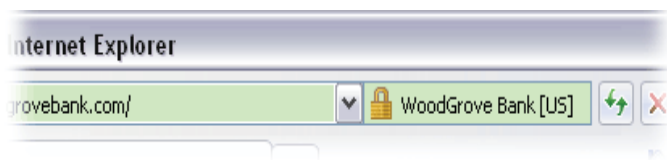

#### New Security Standards in SSL help make SSL a Competitive Advantage

The last few years have seen an unprecedented increase in fraudulent web sites and phishing attacks. In 2005 the leading Certification Authorities and Browser vendors came together and formed the CAB Forum - a membership body designed to standardize issuance procedures of future SSL certificates.

In January 2007 the browser vendor forum members will start to release enhanced versions of their browsers – new browsers capable of identifying which SSL certificates are the new "Extended Validation" (EV) certificates. These next generation browsers activate the new green user interface to show web site visitors when they encounter an Extended Validation certificate, resulting in added trust and peace of mind the web site they are dealing with is authentic and legitimate.



The new IE 7 on Vista interface – the first new browser supporting EV SSL. The EV certificate activates the new green interface and the padlock area now alternates between your company name and country and the Issuing Authority - namely the credible and long time established GlobalSign

#### Why should my company use EV SSL

- Protect your customer's accounts from phishing attacks - any web site that give their customers accounts is a potential phishing target
- Protect your brand from copy cat web sites - ensure customers know the site claiming to be you really is you

#### Who is eligible for EV SSL?

EV certificates are available to Private Organizations, Government Entities, Business entities and non commercial entities such as International Organizations as defined within the CAB Forum EV certificate guidelines.

#### What is the vetting process?

The Extended Validation vetting process establishes the legitimacy of an organization within a specific jurisdiction of incorporation. It also clearly identifies the organizations principle place of business through a rigorous and stringent set of well defined validation processes. The process encompasses authentication of the organizations domain ownership rights as well as contractually binding the organization to a subscriber agreement which benefits relying parties and strengthens the security of the Internet as a whole.


